**The Council** has reviewed our protocol for worship during covid and has decided on the following steps to allow worship while providing for the safety of those attending:

- Continue with the present protocols in worship and entering/exiting the sanctuary.
- All doors will be unlocked to allow for greater access to the church and classrooms.
- Members are encouraged to continue moving through the lower level and throughout the church to avoid congregating in high traffic areas and to maintain social distancing.
- Focus on avoiding activities that would result in groups being in tight proximity for sustained amounts of time.
- Continue with the suspension of the nursery, coffee time and the children's message.
- Continue to encourage the primary use of the West doors so long as the weather allows.
- Members are asked to bring their coats with them into the sanctuary and place either beside them or on the bench in front of them.
- We will continue with similar usher and greeter arrangements along with the handrails being wiped down with disinfectant wipes at various times as members enter and exit the sanctuary.
