From the Facility Team - significant work is underway relating to the parsonage relocation, please be aware of the following items:

1. The site has been staked and marked for digging the basement at the new parsonage location - please do not disrupt those markings and be alert that there are rebar stakes in the prior parking areas.
2. The current plan is to dig the basement on Monday, July 29 and shortly thereafter the wall contractor will begin setting the foundation and walls.
3. For practical purposes, the south lot parking area will no longer be accessible for parking.
4. During the course of the coming week demolition and removal of several items around the current parsonage will take place. Please be alert to those changes and avoid those work areas to the extent possible in the coming weeks.
5. Volunteer help is needed for Saturday - August 3 - please see the separate notice in the PPP and also the email that was sent.

Volunteers needed - preparation for the parsonage relocation is continuing and the facility team is planning a workday and is seeking and needing several volunteers that can help with manual labor on Saturday, August 3. We plan to start the work around 7 AM. Primary tasks that day will include the removal of the brick façade on the south exposure of the parsonage, the removal of concrete from the garage floor and other preparation work. We will have mechanical equipment available to assist in the heavy work but need many hands to help complete the tasks.
