Church Cancellation Policy: If a severe weather warning that poses an immediate and significant danger to the congregation (Tornado Warning, Severe Thunderstorm Warning,

Winter Storm Warning, or Blizzard Warning) has been issued for the area including Sully, and it will be in effect in the hour before and/or the time during the scheduled church function, that function shall be cancelled. If time allows, announcements will be made via TV, radio, e-mail, and calling tree.

For any other event cancellation, a decision will be made by the Executive Committee at least 2 hours before the event and an announcement will be sent to KCWN (99.9 FM) WHO (TV 13) and KCCI (TV 8) as well as sent out on e-mail and the calling tree.

If sirens sound during a church function, attendees will be directed to the basement hallways until the nature of the warning can be determined or an "all clear" is issued by the weather service or the Sully fire department.

Members are always encouraged to use their own good judgment when making the decision whether to leave the house when the weather is questionable.

Members involved in the service are also encouraged to use discretion driving to church in inclement weather.
